WATSON TOWNSHIP PLANNING NEWS 2009-2010

This year was an overall quiet yet, very productive year for the Planning Commission. It also brought along some personnel changes. We said goodbye to a long time member Jim Bass, who is hopefully enjoying good health and a little quieter retirement, thank you Jim for a great tenure. Bruce Bos took Jim's place, while the commissions two other newer members, Troy Baker and Michelle Harris continued to learn, gain experience and offer productive ideas and direction this past year.

We completed the final phase of discussing and updating the master plan; to improve the factual basis for land use decisions and to help to increase the Planning Commission's confidence when it is faced with major land use and zoning decisions for the future. Besides the state mandated law that each townships plan is to be reviewed/updated every 10 years, this phase closely corresponded with the Zoning Ordinance changes we made in 2007/2008, to maintain the rural character of our township and yet provide a structured growth plan for our current and future residents, businesses, and industries.

The Plan Review/Update included the following:

Update and Expansion of "Community Profile": An updated "Community Profile" including a demographic and economic profile based on the most recent data available.

Maps and districts that were updated: **Soils, Prime Farmland, Topography, Drainage and watersheds, Roads, Wetlands, Parcels and recent parcel splits, Land use and cover.**

This community profile is intended to serve as the supporting basis for conclusions drawn and the rationale for many of the master plan's policies and guide the directions of current development patterns, trends and population and land use projections.

Citizen Input: We held some open meeting discussions for the public and the Township Board, to gather their opinions and ideas. We also used these meetings as "spring boards: for ideas and direction that the commission had been working on.

Vision and Goals: The Master Plan update was built upon a realistic understanding of what the Township is today, what the issues and trends are and a consensus of ideas as to what and where the residents of the township want their community to be in 20 or 30 years.

Future Land Use Plan: The future land use plan itself is comprised of at least two parts. A map and a narrative that describes what the map is trying to convey the rational, reasonable, and legal attempts to address the issues and goals set forth. To make the updated plan more meaningful and defensible, each land use category was re-valuated and a rationale for its use in one or more areas of the township was explained and justified. The relationship of each land use category to zoning and utilities (or the lack there of) was reviewed and explains the timing of intended land use changes or the circumstances that might lead to the implementation of a planned land use or zoning change.

Implementation: The master plan is implemented over time. It is also implemented by a variety of entities and individuals including the Township Board, the Planning Commission, private individuals and county and state agencies. The implementation plan identified each of tools needed, tasks that must be accomplished, and the entity or persons that will be responsible. The implementation plan also set priorities.

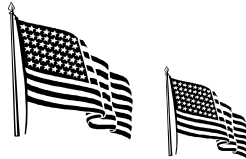

The Hopkins Area Fire Department began providing medical first response MFR on 1 Sept. Our MFR's can arrive minutes ahead of an ambulance and provide the ambulance staff with information on a patient's medical status. Another thing we provide is a calming influence to our patients. We live in the area and chances are we may know our patient. In the months we have provided this service we have responded to many calls in Watson Township. We are training more of our personnel to be MFR's and continue training to maintain our licenses.

We provide traditional fire response, vehicle extrication and rescue, ice/cold water rescue, and now medical first response. In addition we have a fire prevention program we work in the Hopkins Elementary School, St Stanislaus School, and we are trying to bring to a local home school association. If you have a group that we could make a presentation to please let us know.

Remember to call the burn permit line before burning. Call on the day you want to burn and the automated service will record your information. This information will be accessed if a fire is reported in the area. A simple call may prevent a full fire response, and associated costs, to your address.

If you are burning brush or anything at your residence you must call **686-5222** between the hours of 6a.m. and 6p. m., this is an automated phone system. Please call the day you want to burn for the permit, they keep it on file at dispatch for the day.
